Individual support and group activities are provided to help families cope with the challenges they face, learn about their children's visual impairment and how to meet their needs as they grow. In addition the organization helps families access needed resources, learn to advocate for their child, network with other families, participate in community activities, and have fun.

Group recreation and developmental support activities (GRADS) focuses helping the students building independence, social skills and friendships. The families also have access to community programming activities. Programming includes monthly activities during the school year, a tandem cycling program, winter and summer challenge trips, and other group activities that include fitness, recreation and the arts. This program is offered to children from age three to high school.
