IN 2025, WARRIOR-SCHOLAR PROJECT COLLABORATED WITH 23 HIGHER EDUCATION PARTNERS TO PROVIDE COLLEGE PREPARATORY IN-PERSON AND VIRTUAL ACADEMIC BOOT CAMPS AND ONE-DAY COMMUNITY COLLEGE WORKSHOPS TO TRANSITIONING SERVICE MEMBERS AND VETERANS. BOOT CAMP PROGRAMMING SERVED 300 VETERANS, 83 VETERANS WERE SERVED THROUGH COLLEGE SUCCESS WORKSHOPS, AND 29 VETERANS IN THE ON-DEMAND CURRICULUM THAT WAS PILOTED AT THE END OF 2025. WARRIOR- SCHOLAR PROJECT OPERATED 31 WEEKS OF ACADEMIC BOOT CAMP PROGRAMMING, 28 WEEKS IN THE SUMMER, AND 3 WEEKS OF VIRTUAL PROGRAMMING, AS WELL AS 7 SINGLE-DAY COLLEGE SUCCESS WORKSHOPS IN PARTNERSHIP WITH COMMUNITY COLLEGES.
