One Hundred Miles works with citizens and elected leaders to advocate for the passage and enforcement of laws and policies that protect coastal Georgia's wildlife, landscapes, and communities. In the 2025FY, we prioritized work on protecting the saltmarsh from privatization and the Okefenokee swamp from mining, advocating for superfund site cleanup in Brunswick and against harmful rezoning on Sapelo Island, and fighting the warehouse takeover in Chatham, Effingham, and Bryan Counties.

One Hundred Miles works to engage citizens and visitors about the ecological and cultural value Georgia's coast has to offer.
