Community Pillar: AfriFest: Taste of Africa serves as a cultural cornerstone event for the Cincinnati and Northern Kentucky region. This free, family-friendly festival draws an estimated 8,000 to 10,000 attendees annually and hosts between 50 and 75 vendors and exhibitors. Through food, music, art, dance, and cultural showcases, AfriFest promotes community pride, visibility, and appreciation for African heritage. APNET’s Youth Summer Program focuses on cultivating the next generation of leaders. Each year, the program engages approximately 60 to 80 youth, ages 12 to 16, in 4 to 5 Saturday sessions totaling 20 to 30 contact hours. Participants benefit from 10 to 12 skill-building workshops that emphasize leadership, creativity, career exploration, and cultural identity. These interactive experiences provide youth with the confidence and tools to lead in their communities and beyond.

Business: Mixers that attract between 100 and 150 unique participants each year across 3 to 5 curated events. These mixers serve as incubators for collaboration, knowledge exchange, and professional development, helping attendees build valuable relationships and expand their networks. The Business Connect series adds a strategic, cross-continental dimension, bringing together 80 to 100 participants annually, including business leaders, students, and investors from both the U.S. and Africa. Held 2 to 3 times per year, these events foster dialogue on trade, entrepreneurship, and investment opportunities, helping bridge the economic potential between African and American markets.

Networking: The Symposium, APNET’s flagship annual event, brings together an estimated 250 to 300 participants for a day of dialogue, learning, and celebration. In addition to panel discussions and networking sessions, the Symposium proudly awards approximately 8 to 10 scholarships to high school and college students each year, recognizing academic excellence and leadership potential. Furthermore, 3 to 5 community awards are presented during the event, honoring individuals who demonstrate outstanding achievement in professional development, business innovation, and community engagement. The Entrepreneurship Workshop (AEW Series) further supports networking by offering 6-8 training sessions per year, reaching an estimated 60 to 80 aspiring entrepreneurs. These workshops provide guidance on business formation, marketing, intellectual property, and other critical topics, with a focus on supporting immigrants and new business owners.

Explanation: APNET respectfully requests abatement of the penalty assessed under Internal Revenue Code Section 6652(c)(1)(A) for the late filing of its information return. The late filing was due to reasonable cause and not willful neglect. During the filing period, the organization experienced an administrative oversight resulting from a transition in personnel and responsibilities related to tax compliance and financial reporting. The individual responsible for coordinating the preparation and filing of the return was no longer serving in that role, and the filing obligation was inadvertently overlooked during the transition. The organization believed that all required compliance activities had been properly assigned and monitored; however, an internal communication breakdown caused the filing deadline to be missed. Upon becoming aware of the oversight, the organization acted promptly to complete and submit the required return. The organization has consistently sought to comply with all federal filing requirements and has made good-faith efforts to fulfill its tax obligations. The late filing was an isolated incident and was not the result of intentional disregard of IRS requirements. To prevent a recurrence, the organization has implemented additional compliance procedures, including documenting filing responsibilities, establishing a compliance calendar with automated reminders, and enhancing management oversight of regulatory filing deadlines. Based on these facts, the organization exercised ordinary business care and prudence but was nevertheless unable to file the return timely. Accordingly, the organization respectfully requests that the penalty be waived due to reasonable cause.
