28 PROGRAM 1: PHYSICIAN SUPPORT AND EDUCATION THE AUTOIMMUNE ENCEPHALITIS ALLIANCE (AEA) MEDICAL ADVISORY BOARD PROVIDES GUIDANCE TO THE AEA'S PROGRAMS SUPPORTING PHYSICIAN EDUCATION, RESEARCH, AND CLINICAL CARE. THE MEDICAL ADVISORY BOARD (MAB) INCLUDES RENOWNED EXPERTS ON AUTOIMMUNE ENCEPHALITIS (AE) FROM A VARIETY OF KEY DISCIPLINES - NEUROLOGY, RHEUMATOLOGY, AND PSYCHIATRY AND FOCUSES SPECIFICALLY ON CLINICAL CARE AND RESEARCH EFFORTS TO THE AE COMMUNITY. IN ADDITION TO THE MAB, THE AEA'S CLINICIANS NETWORK CONTINUES TO BE A PREMIER SOURCE WORLDWIDE FOR PATIENTS AND CAREGIVERS SEEKING PHYSICIANS WHO HAVE EXPERIENCE TREATING AE. THE PHYSICIANS IN OUR CLINICIANS NETWORK INCLUDE EXPERTS IN THE FIELD OF AUTOIMMUNE ENCEPHALITIS, AND FREQUENTLY PARTICIPATE IN RESEARCH, CONDUCT CLINICAL TRIAL STUDIES, AND SPEAK IN NATIONAL FORUMS ABOUT THIS RARE DISEASE. THE NETWORK IS THE LARGEST NATIONAL REGISTRY OF PHYSICIANS TREATING AE - A TOTAL OF 401 CLINICIANS PARTICIPATING BY 2025 YEAR END. THE AEA PROVIDER EDUCATION SERIES CONTINUES TO PROVIDE ENGAGING DIDACTIC PRESENTATIONS AND INTERACTIVE DISCUSSIONS TO MEMBERS OF THE AEA CLINICIANS NETWORK, THE AEA MEDICAL ADVISORY BOARD AND NEUROIMMUNOLOGY FELLOWSHIP PROGRAMS. EXPERTS IN THE FIELD OF AE VOLUNTEER TO PRESENT FROM THEIR AREAS OF EXPERTISE. THE HOUR IS DEEP DIVE INTO EXPERT KNOWLEDGE AND EXPERIENCE IN THE FIELD OF AUTOIMMUNE ENCEPHALITIS AS WELL AS AN OPPORTUNITY FOR FELLOW PROFESSIONALS TO CONNECT, SHARE INSIGHTS, AND LEARN FROM REAL-LIFE CASES. IT IS AN EXCELLENT OPPORTUNITY TO ENHANCE KNOWLEDGE, NETWORK WITH LIKE-MINDED INDIVIDUALS AND BUILD A STRONGER AE COMMUNITY OF MEDICAL EXPERTS. WHILE THIS IS A PROVIDER ONLY SESSION, ALLOWING THE COMPLETE COMPLICATED NATURE OF THESE CONDITIONS TO BE FULLY DISCUSSED, THE DIDACTIC PORTION IS RECORDED AND SHARED ON THE AEA WEBSITE FOR THE ENTIRE AEA COMMUNITY TO MEET DOCTORS AND LEARN THE MOST CURRENT AE INFORMATION. (NOTE: THE DISCUSSION PORTION IS NOT RECORDED.) DURING 2025, THE AEA OFFERED SEVEN PROVIDER EDUCATION SESSIONS, WITH 236 REGISTRANTS FROM 18 COUNTRIES. (NOTE: IN JUNE 2025, WE BEGAN POSTING RECORDED SESSIONS ON THE AEA YOUTUBE PAGE. CURRENTLY, NINE VIDEOS HAVE RECEIVED A TOTAL OF 1564 VIEWS.) IN 2025, THE AEA PARTNERED WITH PHYSICIAN EXPERTS FROM THE UNIVERSITY OF CALIFORNIA SAN FRANCISCO TO SPONSOR A DINNER AND DISCUSSION AT THE 2025 ANNUAL AMERICAN ACADEMY OF NEUROLOGY MEETING IN SAN DIEGO, CA. THE EVENT ENTITLED "REFLECTIONS ON AUTOIMMUNE ENCEPHALITIS AND ADVANCES IN THE FIELD" INCLUDED PRESENTATIONS FROM 5 RESEARCHERS FROM THE US AND THE NETHERLANDS. THE EVENING ALLOWED OVER 125 ATTENDEES FROM 15 COUNTRIES TO LEARN FROM EACH OTHER AND CREATE NEW RELATIONSHIPS.

AFTER A RIGOROUS REVIEW, THE AEA MAB RESEARCH COMMITTEE PROPOSED A SINGLE APPLICATION TO THE AEA BOARD OF DIRECTORS FOR FUNDING AND APPROVAL. THE PROPOSED PROJECT WAS APPROVED AND FUNDED FOR \$10,000. THE PROJECT HAS DIRECT IMPLICATIONS FOR PATIENTS AND FAMILIES LIVING WITH AE. IN MAY OF 2025 THE AEA CONTINUED ITS SIGNATURE FUNDRAISING EFFORT, RESEARCH NETWORK, TO FUND THE AEA EDWARD ARDITTE COMMUNITY SEED GRANT PROGRAM FOR AE RESEARCH. CONTRIBUTIONS RAISED IN 2025 AS WELL AS RECURRING RESEARCH CONTRIBUTION COMMITMENTS THROUGH JUNE 2026 WILL GO TO FUND THE 2026 SEED GRANT AWARDS CHOSEN IN JUNE.

30 PROGRAM 3: PATIENT SUPPORT, DISEASE AWARENESS AND ADVOCACY IN 2025, 69 SUPPORT GROUPS WERE OFFERED VIA ZOOM TO SUPPORT THE AE COMMUNITY WITH A TOTAL OF 613 ATTENDEES AND 123 UNIQUE INDIVIDUALS. TWO COMMUNITY SUPPORT GROUPS ARE OFFERED EACH MONTH AND FOUR AUDIENCE SPECIFIC GROUPS - PARTNERS, INDIVIDUALS WITH AE, CAREGIVERS ONLY AND BEGINNING AGAIN WITH AE. THE AUDIENCE SPECIFIC GROUPS ALLOW PARTICIPANTS TO SHARE MORE COMPLETELY AND OPENLY THE PERSONAL EXPERIENCES AND CHALLENGES UNIQUE TO THEIR SPECIFIC GROUP TYPE. ALL FIVE SUPPORT GROUPS ARE PEER-LED BY TEN VOLUNTEERS. EACH VOLUNTEER IS EITHER DIAGNOSED WITH AE OR A CAREGIVER. THESE 5 TYPES OF SUPPORT GROUPS MEET A TOTAL OF 6-7 TIMES PER MONTH AND ALLOW PEOPLE LIVING WITH AE TO NOT ONLY SHARE ABOUT THE RARE DISEASE IMPACTING THEIR LIVES BUT ALSO PROVIDE A PLACE THAT NO ONE HAS TO EXPLAIN AND QUESTION IF ANYONE UNDERSTANDS. THESE GROUPS SERVE AS A DISCUSSION LABORATORY FOR THE DEVELOPMENT OF FUTURE LIVING WITH AE PROGRAMS. AS A RARE DISEASE PATIENT ORGANIZATION, THE AEA PARTNERS WITH PHARMACEUTICAL ORGANIZATIONS AND DIAGNOSTIC LABORATORIES COMMITTED TO IMPROVING SOLUTIONS FOR DIAGNOSIS AND TREATMENT OF AUTOIMMUNE ENCEPHALITIS. THESE RELATIONSHIPS ARE CRITICAL FOR COMMUNICATION, EDUCATION AND RELATIONSHIP BUILDING BETWEEN THE SCIENTISTS, RESEARCHERS, BUSINESS PROFESSIONALS, ETC. AND THE PATIENTS AND FAMILY MEMBERS LIVING WITH AE. OUR LONG-TERM GOAL FOR THE 'AE ON THE HILL' PROGRAM IS TO EMPOWER THE AE COMMUNITY TO ADVOCATE FOR THEMSELVES AND THEIR FAMILIES AT THE LOCAL, STATE, AND FEDERAL LEVELS TO IMPROVE THE LIVES OF ALL THOSE AFFECTED BY AUTOIMMUNE ENCEPHALITIS. IN 2025, THE AEA CONTINUED WORKING TOWARD THAT GOAL THROUGH PATIENT AND CAREGIVER STORY TELLING.
