AT OUR MEETINGS HELD IN CITIES AROUND THE US, INNOVATORS EXPERIMENT AND TEST NEW IDEAS, SHARE CUTTING-EDGE PROJECTS, AND FORM NORMS OF COLLABORATION AS THEY SUPPORT ONE ANOTHER IN THEIR WORK.
