We offer voice lessons coachings master classes diction coaching workshops and multiple video-recorded performing opportunities. The program culminates in public performances at Santa Clara University and in the Silicon Valley area. As described by our alumni our program is transformative for them. Accomplishments include yearly public performances of a complete opera plus 50+ opera arias and ensembles with orchestra. Each repertoire piece is carefully prepared with a voice teacher and a coach worked on with a diction teacher worked individually with a conductor and brought for rehearsal with the orchestra. There were. 18 students enrolled and an orchestra of 24 in our last season. Another unique feature of our program is our dedication training young conductors in operatic repertoire. Each conducting student works with the opera singers and coaches under the guidance of a master conductor. Then the repertoire is brought in front of the orchestra where it is rehearsed and then performed in public concert. |
