During 2025, Mind Shift advanced its mission of connecting individuals with meaningful employment while supporting workforce needs for business partners. Operating as an enhanced staffing agency, Mind Shift partners with businesses to connect them with highly capable individuals whose strengths, such as attention to detail, pattern recognition, consistency, and analytical thinking, align with critical workforce needs. Through a business-first model, Mind Shift supports both the employer and the employee, ensuring successful placements that improve retention, productivity, and overall workplace stability. Throughout fiscal year 2025, Mind Shift supported 39 active specialists placed in workforce roles and partnered with 16 active business partners. Additionally, 5 specialists transitioned to direct employment with partner organizations, demonstrating the effectiveness of Mind Shift's training and placement model in creating sustainable employment opportunities.

The Mind Shift Academy, a structured, self-paced training program prepares candidates for the workforce while also helping the organization understand everyone's strengths, preferences, and support needs. Mind Shift does not guarantee job placement; rather, it focuses on equipping candidates with practical skills and insights that increase their employability and long-term success
