Curating Art for Impact offers unique experiential art curated/produced in collaboration w/community partners, with a goal of paying women artists. artBURSTs, a program of Curating Art for Impact, brings more pop-up performances to underserved communities with limited arts access. Pop-up performances include musicians in the backs of pedicabs and visual art work on a mobile billboard truck, in addition to pop up stages occurring where dancers, spoken word artists, and comedians perform.

Girls Create is a summer camp series that empowers young women, ages 12-16, to become future artistic leaders. Girls explore art forms including playwriting, comedy, fashion design, and self-expression through art. Professionals teach, guest artists share their expertise, and mentors from the community guide and encourage empowering girls to lead and to effect change in themselves and others through creative learning. Each week-long session culminates with a performance or exhibit of the participants work with friends, family, and the public.

Read & Rant is Athena Project's monthly book club exploring plays written primarily by women and underrepresented genders. Led by an experienced dramaturg, we read two scripts each month and meet every third Monday online via Zoom. We explore brand new works with playwrights in the room and we discuss what makes a good script, how it affects us, and how it links to the larger world.

Creative Arts Workshops offers dynamic sessions in a variety of artistic disciplines to encourage girls and nonbinary youth as well as women 55+ to tap into their creativity, gain confidence and find their artistic voice. Offerings include Rebel Arts which centers women ages 55+, providing professional guidance & instruction in various artistic disciplines, including visual art, storytelling & movement; G.R.R.L.S Create (Grow, Rise, Rebel, Lead, Shine) centers theatre, creative writing, fashion, poetry, and comedic disciplines, giving middle school girls and nonbinary youth a chance to nurture empathy for themselves and others while gaining mental health and mindfulness tools for resilience; and monthly Artfully Minded workshops, unleashing creativity for youth 8-18 yrs to lead and effect change in themselves and others through creative learning. Workshops are offered in the following performing art forms: spoken word, poetry, music, playwriting, acting/monologues, stand-up, and dance. Workshops are almost always free or low cost to participants.

Comics Sound Off is a new monthly community group of comedians, led by Janae Burris, that meets virtually to learn from each other, receive training to grow and celebrate our voices in comedy.
