BBC CONTINUED ADVANCING EQUITABLE MATERNAL HEALTH OUTCOMES THROUGH CULTURALLY RESPONSIVE, COMMUNITY-BASED CARE, ACHIEVING AN 85% FULL-TERM BIRTH RATE AND AN 83% BREASTFEEDING INITIATION RATE, BOTH EXCEEDING LOCAL, STATE, AND NATIONAL AVERAGES.
