CASE MANAGEMENT: IN 2025, THE CRCTV STAFF SPENT 299.25 HOURS PROVIDING CASE MANAGEMENT SERVICES TO 252 HOUSEHOLDS. THIS PROGRAM ASSISTED CLIENTS WITH MULTIPLE SERVICES TO CONNECT THEM TO NECESSARY RESOURCES SUCH AS ENERGY ASSISTANCE PROGRAMS, EMPLOYMENT, HOUSING, FOOD PROGRAMS AND OTHER MEANS OF ASSISTANCE TO ENSURE CLIENTS BECOME MORE STABLE. CRCTV STAFF ALSO PROVIDED 441.75 HOURS OF DIRECT CONTACT WITH CLIENTS AND ASSISTED THEM BY PROVIDING 113.5 HOURS OF ADVOCACY WORK WITH LANDLORDS AND OTHER AGENCIES ON THEIR BEHALF. THROUGH OUR CASE MANAGEMENT SERVICES AND APPLICATION ASSISTANCE, OUR CLIENTS RECEIVED 13,824.00 IN ASSISTANCE FROM OTHER LOCAL, REGIONAL, AND STATE PROGRAMS FOR RENT, UTILITIES, AND OTHER BASIC NEEDS.

HOUSING SECURITY DEPOSIT PROGRAM: THE HOUSING SECURITY DEPOSIT PROGRAM AIMS TO REDUCE THE FINANCIAL BARRIER TO SECURING HOUSING BY PROVIDING ASSISTANCE WITH RENTAL SECURITY DEPOSITS TO ELIGIBLE PERSONS IN ACCORDANCE WITH HUD AREA INCOME LIMITS AND OTHER PROGRAM REQUIREMENTS. THE PROGRAM PAYS THE FULL AMOUNT OF THE TENANT'S SECURITY DEPOSIT BY THE MOVE-IN DATE IN THE FORM OF AN INTEREST-FREE LOAN AND THE TENANT IS RESPONSIBLE TO MAKE MONTHLY PAYMENTS TO THE COMMUNITY RESOURCE CENTER OF TETON VALLEY UNTIL THE LOAN AMOUNT IS PAID IN FULL. IN 2025, THE CRCTV DISBURSED 8,450.00 IN SECURITY DEPOSITS TO LANDLORDS ON BEHALF OF 8 HOUSEHOLDS AND RECEIVED 2,026.73 IN LOAN REPAYMENTS FROM PROGRAM PARTICIPANTS.

OTHER COMMUNITY RESOURCE CENTER PROGRAMS ARE IN LINE WITH THE ORGANIZATION'S MISSION TO SERVE COMMUNITY MEMBERS BY PROVIDING IMMEDIATE ASSISTANCE, ESSENTIAL RESOURCES, AND CONNECTIONS TO ACHIEVE SELF- SUFFICIENCY. IN COLLABORATION WITH THE EDUCATION FOUNDATION OF TETON VALLEY, THE TETON VALLEY CARES EVENT HAS CONTINUED TO HAVE IMPACTFUL ATTENDANCE. THIS EVENT PROVIDES FREE MEDICAL, VISION, HEARING & DENTAL SCREENINGS, HAIRCUTS, AT-HOME EDUCATIONAL SUPPLIES, CLOTHING, TOILETRIES AND CONNECTION TO LOCAL RESOURCES TO ENSURE THAT OUR COMMUNITY'S YOUTH AND THEIR FAMILIES ARE ABLE TO GO INTO THE NEW SCHOOL YEAR PREPARED. IN 2025, WE SERVED 160 STUDENTS AND THEIR FAMILIES. THE COMMUNITY RESOURCE CENTER'S FIREWOOD RESCUE PROGRAM, NEW IN 2023, HAS SEEN SUBSTANTIAL GROWTH OVER THE LAST TWO YEARS. PARTNERING WITH LOCAL LANDOWNERS AND TREE REMOVAL COMPANIES, VOLUNTEERS PROCURED APPROXIMATELY 30,000 POUNDS OF WOOD THAT WAS THEN SPLIT AND BUNDLED FOR EASIER DISBURSEMENT TO RECIPIENTS IN NEED OF SUPPLEMENTAL FIREWOOD TO KEEP THEIR HOMES WARM IN WINTER. IN 2025, 858 BUNDLES OF WOOD WERE DISBURSED TO 21 UNIQUE HOUSEHOLDS. THE PROGRAM ALSO PROCURED A PERMANENT ON-SITE STORAGE SHED, CONSTRUCTED IN-KIND BY LOCAL CONSTRUCTION PARTNERS, TO KEEP BACK- STOCK OF BUNDLES DRY THROUGHOUT THE WINTER. FOOD FOR GOOD IS OUR FOOD RESCUE PROGRAM, WHERE FOOD THAT IS JUST EXPIRED, BRUISED, OR OVERSTOCKED IS RESCUED AND RE-DISTRIBUTED TO ANYONE WHO NEEDS IT. IN 2025, VOLUNTEERS RESCUED FOOD TOTALING 14,500 POUNDS FROM AREA GROCERY STORES AND RESTAURANTS. THIS FOOD WAS SUBSEQUENTLY RE-DISTRIBUTED AT VARIOUS TIMES AND LOCATIONS THROUGHOUT THE COMMUNITY AS FREE FOOD FOR ALL. ANY FOOD NO LONGER APPROPRIATE FOR HUMAN CONSUMPTION WAS PROVIDED TO LOCAL FARMS FOR COMPOST AND FARM ANIMAL FOOD. OUR HOME GOODS PANTRY AIMS TO COMBAT HYGIENE POVERTY IN TETON VALLEY BY PROVIDING SEASONAL CLOTHING ALONG WITH BASIC HOUSEHOLD AND HYGIENE SUPPLIES FOR FREE, AVAILABLE TO ANYONE IN NEED. IN 2025, THE PANTRY WAS ABLE TO KEEP THE SHELVES STOCKED THROUGHOUT THE YEAR THANKS TO IN-KIND DONATIONS FROM THE COMMUNITY AND CORPORATE DONORS AS WELL AS GRANT FUNDING FROM SELECT HEALTH. ACROSS ALL IMMEDIATE ASSISTANCE PROGRAMS, 11 VOLUNTEERS LOGGED 499.25 HOURS OF SERVICE.
