Doctors for Drug Policy Reform (D4DPR) is organized and operated exclusively for charitable and educational purposes to advance public health through evidence-based drug policy reform. The organization educates policymakers, health professionals, and the public on the health effects of drug use and the consequences of drug laws; develops and disseminates scientific, clinical, and policy analyses; and promotes approaches that reduce harm, improve access to treatment, and decrease stigma associated with substance use disorders. 28 Expansion of Mission and Public Health Scope During the reporting period, D4DPR continued its transition from a cannabis-focused organization to a broader public health-oriented organization addressing drug policy across all illegal drugs. This expansion enabled the organization to engage a wider range of physicians, scientists, and health professionals; address emerging and complex drug-related public health issues; and contribute to national and international discussions on evidence-based, health-centered drug policy. This work supports the organization's charitable purpose by reducing stigma, improving public understanding, and promoting policies that enhance health outcomes.
