RAINN also operates the Department of Defense Safe Helpline, services for members of the U.S. military affected by sexual assault, through a contract from DoD. All services are provided free. They are confidential, anonymous, and available 24/7.

Public Education: RAINN educates the public about sexual violence, working with national media and the entertainment industry to elevate sexual violence storylines and reach millions of homes. We also operate rainn.org and social media platforms to provide information about sexual violence, connect people to support, and engage with communities about these issues. Through a national speakers bureau and other community activities, RAINN is able to mobilize the public to share important information about preventing and recovering from sexual violence.
