SERVING AN AVERAGE OF 298 HOUSEHOLDS PER MONTH, 337,821 POUNDS OF FOOD, VALUED AT \$584,430, WAS DISTRIBUTED TO NEIGHBORS IN NEED. LAUNCHED IN 2023, THIS PROGRAM OFFERS TWICE MONTHLY WORKSHOPS FOR CLIENTS AND COMMUNITY MEMBERS TO LEARN ABOUT LOCAL RESOURCES AVAILABLE TO HELP THEM INCREASE INCOME AND DECREASE EXPENSES. LED BY VOLUNTEER FACILITATORS, IN 2025, 22 WORKSHOPS WERE HELD WITH A TOTAL OF 117 ATTENDEES. IN THE FALL OF 2025, THE WORKSHOP WAS EXPANDED TO A TWO PART SERIES, ADDING A SECOND WORKSHOP IN WHICH ATTENDEES RECEIVE ONE-ON-ONE COACHING TO DEVELOP A HOUSEHOLD PLAN BASED ON THEIR EXPENSES AND INCOME.

HOME REPAIRS TOTALING \$38,363 WERE ACCOMPLISHED IN 2025 COVERING 7 SEPARATE PROJECTS. THE BACKPACK BUDDIES PROGRAM PROVIDES BAGS OF INDIVIDUALLY WRAPPED FOOD ITEMS EVERY WEEKEND DURING THE SCHOOL YEAR TO STUDENTS WHO RELY ON THE SCHOOL MEAL PROGRAMS DURING THE WEEK. ALL 7 JAMES ISLAND SCHOOLS ARE SERVED, AND THE PROGRAM IS ADMINISTERED COMPLETELY BY VOLUNTEERS. IN 2025, NEARLY 200 STUDENTS EACH SCHOOL WEEK BENEFITTED FROM THIS PROGRAM.
