EMERGENCY SHELTER FOR WOMEN & CHILDREN: PADV CORE PROGRAM, EMERGENCY SHELTER FOR ADULTS AND CHILDREN, 24 HOUR EMERGENCY SHELTER, 24 HOUR CRISIS STABILIZATION SUPPORT, CASE MANAGEMENT, SUPPORT GROUPS AND MORE. TWO SHELTERS ARE ONLY STATE CERTIFIED IN THE CITY OF ATLANTA AND GWINNETT COUNTY. THE PROGRAM PROVIDES A SAFE HAVEN FOR VICTIMS OF DOMESTIC VIOLENCE AND THEIR CHILDREN, AND OFFERS SHELTER, NECESSITIES, FOOD, CLOTHES, AND SUPPORT GROUPS, CASE MANAGEMENT, MENTAL AND MEDICAL HEALTHCARE, TRANSPORT AND JOB OPPORTUNITIES. OFTEN WE ARE THE FIRST LINK TO SAFETY PLANNING, INFO, AND SUPPORT TO CALLERS IN DANGER AND THOSE WITH BATTERY QUESTIONS.

SERVICES INCLUDE CASE MANAGEMENT, ADVOCACY, PUBLIC BENEFIT ASSESSMENT AND ASSISTANCE, SUPPORT GROUPS AND HOUSING REFERRALS, CHILDCARE, MENTAL AND MEDICAL HEALTHCARE, TRANSPORTATION AND JOBS.
