STAFF OFFER PARENTING EDUCATION, SUPPORT, AND INFORMATION ON COMMUNITY RESOURCES FOR UP TO 4 YEARS AFTER THE BIRTH OF A CHILD. FAMILIES RECEIVING INTENSIVE HOME VISITING ARE MORE LIKELY TO BE LINKED TO A MEDICAL PROVIDER (CURRENTLY 98%) AND HAVE CHILDREN FULLY IMMUNIZED; THEY ARE MUCH LESS LIKELY TO HAVE A REPEAT TEEN PREGNANCY (CURRENTLY JUST 1 OUT OF 37 PARTICIPATING TEENS) OR SUBSTANTIATED ABUSE OR NEGLECT.
