ESNG's Early Education and Care Program includes Head Start, Early Head Start, Georgia Pre-K, and the USDA Nutrition Program. ESNG provides NAEYC-accredited, comprehensive early education services to more than 2,040 children living in poverty across 20 locations in Metro Atlanta, DeKalb, and Northeast Georgia. In 2025, 90% of four-year-olds who graduated from the program met or exceeded developmental expectations. In addition, ESNG supported families through a wide range of services, including job training for 136 families, emergency or crisis-directed assistance for 392 families, and mental health services for 121 families. ESNG also provided 167 points of service to families addressing chronic health conditions. During the year, 1,703 children received preventive and ongoing medical services, and 1,208 children received ongoing oral health education and dental services.

ESNG's Early Intervention Program administers the Babies Can't Wait Early Intervention Program and serves children in Gwinnett, Newton, and Rockdale Counties. The program provides critical early intervention services to 2,944 children with disabilities from birth to three years of age, including physical, occupational, and speech therapy; special instruction; autism services; family training; and service coordination. Outcome measures show that more than 95% of children demonstrated substantial improvement in social-emotional, cognitive, language, and behavioral skills. Additionally, more than 95% of families increased their knowledge of their rights, improved their ability to effectively communicate their child's needs, and strengthened their ability to support their child's development and learning.

Over the past year, the Foster Grandparent Program has continued to make a lasting impact in our community through dedicated service and meaningful intergenerational connections. Our Foster Grandparents contributed more than 58,000 volunteer service hours, providing one-on-one support, mentorship, and care to over 100 Head Start and Early Head Start children across our learning centers. Through their consistent presence, volunteers helped children strengthen literacy, numeracy, social-emotional development, and classroom engagement. Teachers and program staff reported measurable improvements in children's performance, with outcomes showing that 89% of children served by Foster Grandparents demonstrated developmental progress. The program currently includes 61 active volunteers. In addition to supporting children, the program also enriched the lives of our senior volunteers. Many reported a stronger sense of purpose, deeper community connection, and improved emotional well-being as a result of their service.
