Meal Service Program: Prepare and deliver nutritious meals to homebound and elderly residents Monday-Friday. Clients pay for services on a sliding scale based on income. In 2025, we provided 119,287 meals to 886 clients; 56% of clients received our Meal Service Program free of charge. We rely on 50+ volunteers each day to deliver the hot meals, social connection and a wellness check.

Pet Love Program: Assist homebound clients with cat and dog food. For seniors living alone, their pet may be the closest companion and one of their only sources of consistent comfort.
