ALL PROGRAM SERVICES ARE PROVIDED THROUGH THE HIGH SCHOOL PROGRAM AT NEW VILLAGE GIRLS ACADEMY. NEW VILLAGE INTENTIONALLY SEEKS AND SERVES VULNERABLE, DISADVANTAGED, AND UNDERSERVED YOUNG WOMEN AND GENDER-EXPANSIVE YOUTH WHO FACE EXTREME PERSONAL CIRCUMSTANCES THAT INTERFERE WITH EDUCATIONAL PROGRESS. DURING THE YEAR, THE SCHOOL SERVED 136 STUDENTS THROUGH AN INTEGRATED MODEL THAT COMBINES STANDARDS-ALIGNED ACADEMIC INSTRUCTION, COMPREHENSIVE WRAPAROUND STUDENT SUPPORT SERVICES, AND COLLEGE AND POSTSECONDARY READINESS PROGRAMMING. THIS MODEL PRIORITIZES ADDRESSING STUDENTS' CRITICAL UNMET NEEDS WHILE SUPPORTING ACADEMIC PROGRESS, GRADUATION, AND SUCCESSFUL TRANSITIONS AFTER HIGH SCHOOL. AS A RESULT, THE SENIOR CLASS ACHIEVED A 95% GRADUATION RATE, AND 76% OF THE 21 GRADUATING SENIORS PLANNED TO CONTINUE TO COLLEGE OR ANOTHER POSTSECONDARY PATHWAY.
