HOME OWNERSHIP PROGRAM - Habitat for Humanity partners with families in need to build safe, decent, and energy efficient homes. Our homes are designed for lasting affordability and to meet the needs of homeowner families. By utilizing the labor of volunteers and future homeowners, using efficient building techniques, and utilizing donated materials, Habitat offers homes to working families using affordable, non-interest-bearing mortgages. This model makes home ownership accessible and sustainable for families in need. Attainable home ownership creates stability, reduces stress, and fosters self-reliance and confidence. Studies show that stable homes play a crucial role in healthy child development. When a home supports health, safety, and security, it provides a strong foundation for families to thrive. Home ownership also empowers families to save for the future, invest in education, and pursue career growth, ultimately lifting the entire family. Indian River Habitat launched its ambitious housing counseling program (HCP) with an overarching goal to provide financial counseling and education to become fully equipped to make informed decisions along the pre-purchase and post-purchase home ownership continuum. The design flow of the HCP is systematic, and it is geared toward reducing or eliminating potential barriers, resulting in the opportunity to deepen and lengthen our reach. Standard HUD guidelines and practices are established to direct families through a series of distinct steps, from completing an intake packet to fulfilling the requirements of one of three home ownership paths - an open market purchase, entrance into the Habitat Homeownership Program, or ongoing counseling for families that are currently unqualified to purchase a home. Indian River Habitat is confident that this program will help additional families achieve home ownership. In fiscal year 2025, Indian River Habitat for Humanity helped more than 68 households with 154 individuals through our long-term home ownership and financial literacy program along with housing counseling services.

HABITAT'S RESTORE - Habitat's ReStore serves a dual purpose: generating revenue to support our affordable homeownership program and offering home furnishings, appliances, building materials, and other essential items to homeowners and the public at significantly reduced prices. The store's inventory is made possible through generous donations of new and gently used items from businesses and individuals. To minimize operating costs and foster community engagement, homeowners and volunteers contribute their time in the ReStore, earning sweat equity hours while supporting Habitat's mission.

NEIGHBORHOOD REVITALIZATION PROGRAM - Indian River Habitat's Neighborhood Revitalization Program (NR) is a focused housing outreach program that offers affordable critical repairs to qualifying homeowners in Indian River County. Habitat's NR program unites community stakeholders in supporting residents by responding to needs among low- to moderate-income homeowners, veterans and seniors living on a fixed income. Through this program, Habitat seeks to build new partnerships and empower residents to revitalize neighborhoods and ultimately enhance their quality of life. In FY 2025, the NR program provided critical home repairs to 111 homes.

Indian River Habitat for Humanity is committed to efficiency and transparency. We communicate with our supporters, donors, and prospective donors by email, postal mail, phone, and other means, both to request contributions to our cause and to educate the public about Indian River Habitat for Humanity's year-round programs, volunteer opportunities, and other events in local communities and around the world. These efforts help advance our mission to put God's love into action by bringing people together to build homes, communities, and hope. As a nonprofit organization that is exempt from federal taxation, we ensure our donors' money is spent as efficiently and effectively as possible. Additionally, we have certain expenses that cannot be billed separately for each functional area. Rent, utilities, information technology, and other costs are grouped together. We allocate these costs in compliance with Generally Accepted Accounting Principles, or GAAP, across the Program (including Habitat Restores), Management & General, and Fundraising categories. Finally, some staff members have responsibilities that cross over functional areas. To calculate the time allocation, Indian River Habitat for Humanity divides the number of hours spent on a project outside of a staff member's designated expense category by the total hours worked during that period and allocates that percentage of costs to the appropriate expense category.

We allocate these costs in compliance with Generally Accepted Accounting Principles, or GAAP, across the Program (including Habitat Restores), Management & General, and Fundraising categories. Finally, some staff members have responsibilities that cross over functional areas. To calculate the time allocation, Indian River Habitat for Humanity divides the number of hours spent on a project outside of a staff member's designated expense category by the total hours worked during that period and allocates that percentage of costs to the appropriate expense category.
