ALSO, IT PROVIDED SCIENTIFIC INPUT INTO REGULATORY PROCESSES THAT AFFECT RIVER FLOWS IN THE YUBA BASIN. THE WATERSHED SCIENCE PROGRAM INCLUDES THE EDUCATION PROGRAM WHICH BROUGHT EDUCATIONAL PRESENTATIONS ON WATER CONSERVATION AND FISH HABITAT TO SCHOOLS IN NEVADA COUNTY AND SURROUNDING COUNTIES. RIVER MONITORING, ANOTHER COMPONENT OF RIVER SCIENCE, ENTERED ITS 24TH YEAR, AND CONTINUED TO MONITOR THE WATER QUALITY OF THE YUBA RIVER USING VOLUNTEER CITIZEN-SCIENTISTS TO COLLECT DATA SO THAT ANY POTENTIAL THREATS COULD BE DETECTED. EACH YEAR, MORE THAN 80 RIVER MONITORS COLLECT HIGH QUALITY DATA AT NEARLY 40 SITES.

THIS PROGRAM CONTINUES TO COORDINATE ONE OF THE LARGEST RIVER CLEANUPS IN CALIFORNIA WITH MORE THAN 800 VOLUNTEERS.
