THE APPLICATIONS ARE DISTRIBUTED TO ALL OF THE COMMITTEE MEMBERS WHO REVIEW THEM INDIVIDUALLY AND THEN RANK THEM IN THE ORDER IN WHICH THEY BELIEVE THE SCHOLARSHIPS SHOULD BE GRANTED. THE COMMITTEE CHAIRMAN THEN TABULATES THE RESULTS FROM THE COMMITTEE MEMBERS AND ANNOUNCES THE WINNERS.
