Trauma-Informed Therapy and Family Advocacy-The Center delivered trauma-informed therapeutic services and family advocacy to child victims and their non-offending caregivers at no cost. Licensed therapists provided counseling to support healing and recovery, while family advocates assisted caregivers in navigating the legal, medical, and social service systems. These services promote emotional well-being and long-term stability for children and families affected by abuse.

4b (Code:) (Expenses \$ 305,314 including grants of \$) (Revenue \$)

Forensic Interviewing-The Childrens Advocacy Center provided forensic interviews in a safe, child-friendly environment for children who were alleged victims of abuse or neglect. Trained forensic interviewers conducted neutral, developmentally appropriate interviews to reduce trauma and limit the need for multiple interviews. These services supported coordinated investigations and helped ensure children were protected and connected to needed services.

Multidisciplinary Team Coordination and Prevention Education-The Center coordinated a multidisciplinary team response involving law enforcement, child protective services, medical and mental health professionals to ensure a comprehensive approach to child abuse cases. In addition, the organization provided community education and prevention efforts to raise awareness, promote early reporting, and strengthen community capacity to protect children.
