Pt I Line 2	Habitat for Humanity of Florida provides grant funding to local habitat affiliates across Florida to aid disaster recovery efforts by providing affordable housing solutions and assistance for survivors. Written subgrant agreements outline expected performance metrics around new housing units built, homes repaired, and rebuilds completed, as well as other interventions like debris removal that help impacted communities recover. Regular monitoring occurs before, during, and after the grant term through predetermined checkpoints written into every disaster recovery subgrant contract. This includes a mid-grant review and final assessment, as well as monthly meetings for open communications. Monitoring examines quantitative metrics tracking categories such as: new affordable homes constructed for survivors; repairs and rebuilds; completed habitability assessments conducted; post disaster number of debris cleanups for affected areas; other assistance activities like goods distribution if needed for recovery; and equity metrics including ethnicity, income, gender, age, and veteran status. The monitoring process also requires adherence to Habitat for Humanity International and state standards including adherence to federal fair housing laws and best practices, completion of annual third-party audits, standardized Board governance requirements, standardized quarterly reporting, and execution of Habitat for Humanity U.S. construction standards outlined in the Habitat Strong program
