Land Conservation GVLТ furthered its mission to conserve working farms and ranches, wildlife habitat, and river corridors in Southwestern Montana. We identify strategic areas with high conservation values and conserve blocks of open land that protect special parts of our landscape. We hold 135 conservation easements covering 74,764 acres. Our staff visit each conservation easement annually to monitor their condition and partner with landowners on restoration projects to improve eroding streambanks, plant vegetation, and enhance floodplains. In FY25, we conserved 5,938 acres of land in priority conservation focus areas, including Paradise Valley, East Gallatin, and Amsterdam/Churchill. We also launched Northern Yellowstone Open Lands, a regional initiative serving Park County, Montana landowners and communities who are committed to preserving the regions unparalleled landscapes and working lands.

Community Trails GVLТ connects people, communities, and the land through public trails and collaborative trail projects. We completed the Burke Park Traverse; trail enhancements to Triple Tree, Drinking Horse, and Painted Hills trails; and created all-abilities trails in Sunset Hills. Staff and 511 volunteers spent over 1300 hours maintaining trails at Burke Park, Drinking Horse, and Triple Tree . We also partnered with other local recreation groups on an Outside Kind campaign to share messages about considerate trail and outdoor etiquette.

Education GVLТ shares news with over 10,000 monthly e-newsletter subscribers and more than 16,000 social media followers on community trails, private land conservation, and related public events. GVLТ publishes our audited financial statements, IRS Form 990s, and annual reports on our website. The 22 rising leaders on the NextGen Advisory Board educate and inspire their peers to volunteer and support GVLТ. Our Trails team hosted 511 volunteers for over 1300 hours of service and educated them all on GVLТs mission and accomplishments. Through a partnership with Random Acts of Silliness, we brought the trails to life with the ever-enchanting Bumblewood Thicket Fairy Village, introducing many first-time users to the trail system. The Summer Trails Challenge engaged thousands of community members to explore the trails and log 114,095 miles of trail use in four weeks.
