COMMUNITY LAND AND WATER COALITION, INC. - In March 2025, Save the Pine Barrens, Inc. changed its name to Community Land and Water Coalition, Inc. (CLWC), expanding its grassroots network to engage the public in land use planning to protect land and water resources and to inform residents about municipal hearings and permitting processes.

STANDING TREES - At the federal level, Standing Trees worked to ensure that US Forest Service logging projects in the Green and White Mountain National Forests adhered to federal laws by submitting technical comments, recruiting news stories, educating the public and elected officials, and filing litigation.

HOODWINKED IN THE HOTHOUSE continued to expand its reach and influence with our education and movement building activities opposing false solutions to climate change. This included distributing our flagship publication Hoodwinked in the Hothouse through direct shipments, expanding our web and social media presence, and providing support and connections to groups fighting false solutions.

CAMPAIGN TO STOP GE TREES - The Campaign to STOP GE Trees made significant advances to prevent the large-scale and/or commercial release of genetically engineered (GE) trees into the environment. We used documented problems with a GE chestnut tree known as D54/58 to show what can go wrong with genetically engineering trees, and it will be a key part of our ongoing work to stop future iterations of GE trees.

GLOBAL JUSTICE MEDIA PROGRAM - GJEP created 7 Breaking Green Podcasts that reached thousands of people with information about local, national and international human rights and environmental issues. BIOFUELWATCH undertakes advocacy and campaigning in relation to the climate, environmental, human rights and public health impacts of large-scale industrial bioenergy. Activities responded to a mission driven vision to promote environmental decision-making in relation to bioenergy and other bio-based products.

HONDURAS NOW was involved in various education projects including two North American delegations to Honduras and a report launch regarding the environmental impacts of investment-state dispute mechanisms (ISDS) on Honduran communities.

NH PANTHER (Plymouth Area To Help End Racism) continued our operations as a small, volunteer-run, grassroots community organization. We accomplish our mission to help end racism and systemic biases through community engagement, direct mutual aid, education and curriculum reform, youth empowerment programming, and the arts.

ITINERANT UNIVERSITY OF RESISTANCE IN HAITI (UNIR-Haiti) reaffirmed its conviction that it is possible to build collective alternatives under adverse social, territorial and security conditions in Haiti, especially when women and communities occupy a central place in the processes of organizing, training, and defending their territory. UNIR in Haiti focused on three strategic areas: defending the territory through community-based assessments, political and pedagogical training, and local, regional, and international collaboration. UNIR in Haiti expanded its online course platforms, reaching over 200 enrollments during 2025, primarily from women and young people. These capacity building spaces facilitated access to educational and linguistic tools. UNIR in Haiti supported 7 scholarship recipients who participated in training and organizational strengthening processes. At the local level, UNIR in Haiti consolidated a strategic alliance with a school in the Jacmel region, which allowed for the expansion of community work and provided a stable space for educational and organizational activities. Across all sectors, FANM YO LA, created by women for women, was consolidated, reaffirming the role of Haitian women as fundamental political subjects in the defense of territories. We held Spanish courses in 4 communities in the North of the country: Cadush, Terrier Rouge, Ouanaminthe and Carice, and launched the A1 Spanish course in online format. UNIR-Haiti has established a collaboration agreement with the Abricot National School, located in Kap-Wouj, a community committed to transformative education. This is a historic moment for UNIR, as it represents the beginning of a new chapter in our work for quality Popular Education with a Latin American focus. This year, the Fanm Yo La subprogram is expanding and strengthening through activities that guarantee the active participation of Haitian women, through meetings, following up with scholarship recipients, and reviewing 26 applications for the Fanm Yo La grant. The evaluation committee selected Rooseverlande Amajuste, Rachele Mompremier, and Johanne Boutin.

THE GRASSROOTS CENTER recovered from the fire which took our community center in August of 23. Henry Harris assumed a temporary paid position to oversee demolition, cleanup, and partial rebuild of infrastructure, and began two new programs: preparing for a roadshow and undertaking a statewide collaboration to start public programming in 2026 as we finish off our recovery process at our community land project. We replaced tools and equipment, managed an ongoing community outreach campaign, and convened a number of bilateral and network meetings with our staff time
