FY25 Narrative In Beloved Community's eighth year we supported 19 organizations with ongoing facilitations, trained 528 organizational leaders in operationalizing their commitments to equity for all. 74% of our organizations were in our workforce portfolio, reflecting the continued growth of our Good Jobs Coalition. We celebrated the following impact and milestones: 1) Awa By Beloved Tool Suite: In FY25, 13 organizations completed the Equity Audit. The work of these leaders impacted 1,089 full-time staff across their respective organizations. 2) Power to Make Change: In FY25 we presented findings and recommendations to the New Orleans Early Education Network based on our brief: Expanding Access to Early Education Opportunities for Latine Families in Orleans Parish. Key findings included: Collaborate with Latine families to identify which settings they value for early childhood education Budget for language access support for job recruitment and professional development, not just community outreach and enrollment Create a comprehensive guide to early childhood access for newcomer families Consider replicating HeadStarts Dual Language Assessment to standardize assessment across all providers regardless of size Ensure that local policy, data collection, programs, and ongoing professional development includes inclusive values and embeds the importance of cultural competency. Provide an updated intake form in English and Spanish where families respond to questions about race, ethnicity, and languages spoken. If families are not literate, an employee can facilitate. Disaggregate and analyze program data by race and ethnicity to better understand who is making use of publicly funded early programs. Identify opportunities within the region to strengthen, resource, and support informal networks of Latine family child care workforce entrepreneurs. Consider replicating Jefferson Ready Start Networks two-generation workforce training program and application partnership with La Voz. Learn from effective programs around the country and other local early childhood exemplars that are effectively meeting the needs of cultural communities, for example, Charlotte Bilingual Preschool in North Carolina or Centro Tyrone Guzman in Michigan.
