Initially engaging those who were feeling lonely and isolated due to the pandemic, the program lifts the spirits of anyone who is feeling low by engaging them in song, imbuing them with "vitamin H for Harmony" as one artist said, and providing a means for them to connect with others. Arts Alive Seniors Outreach Program: Our Arts Alive program at County Senior Centers, rec centers, and senior living communities provides the opportunity for seniors to join actively in various forms of art and movement with other seniors, building connections and honing new skills. Led by skilled teaching artists, seniors experience thinking, creativity, and experimenting and report "wonderful feelings... very happy and fulfilled."

Our Arts Camp program is comprised of sleepaway and day camps. At weeklong sleepaway arts camp on Maryland's Eastern Shore, campers are provided a safe space to explore new art forms, see the world through a fresh lens, and build friendships. The primary focus is on the visual arts, with a healthy dose of song and dance, outdoor activities and field trips. Our weeklong day camps are located in the Takoma Park/Silver Spring area of Maryland, with a one week arts camp for elementary school, a one week camp for middle schoolers that emphasizes arts for social change, and one-week Spanish immersion arts camps.
