THIS CREATED 96 TEAMS WITH 931 COACHES AND 1,466 STUDENT ATHLETES WITHIN THE STATE OF GEORGIA. GEORGIA CYCLING ORGANIZES AND EXECUTES NINE EVENTS EACH YEAR FOR THE TWO PROGRAMS.
