BETWEEN THE TWO LOCATIONS, GENESIS PROVIDED A TOTAL OF 6,476 CHARITY MEDICAL, DENTAL, MENTAL HEALTH COUNSELING, COMMUNITY HEALTH CONSULTATIONS, MEDICATION ASSISTANCE, AND SPECIALTY CARE COORDINATION ENCOUNTERS TO LOW-INCOME UNINSURED INDIVIDUALS AS AN EXPRESSION OF THE LOVE OF CHRIST. THE BREAKDOWN OF SERVICES IS MEDICAL, 2,383; DENTAL, 1,108; COUNSELING, 480; COMMUNITY HEALTH, 1,866; MEDICATION ASSISTANCE, 233; AND SPECIALTY COORDINATION, 406.
