MORE THAN 190,000 VISITS TO THE MONTCLAIR PUBLIC LIBRARY TOOK PLACE IN 2025, AND THE FOUNDATION SUPPORTS PROGRAMS AND SERVICES THAT BENEFIT THE WHOLE COMMUNITY. WHILE MUNICIPAL FUNDING PROVIDES FOR BASIC LIBRARY SERVICES (STAFFING, UTILITIES, BUILDING MAINTENANCE, ETC.), THE FOUNDATION SUPPORTS PROGRAMMING AND SPECIAL PROJECTS THAT MAKE OUR PUBLIC LIBRARY TRULY UNIQUE. FROM EARLY CHILDHOOD LITERACY TO PROGRAMS FOR SENIORS, THE FOUNDATION HELPS EXPAND THE LIBRARY’S REACH AND PROVIDES NEEDED SERVICES TO THE PEOPLE IN OUR COMMUNITY.
