THE FORUMS REACH OVER 41,000 INDIVIDUALS FROM THE VETERINARY INDUSTRY INCLUDING: SUPPORT STAFF, VETERINARY TECHNICIANS, STUDENTS, AND DVMS. LIFEBOAT PROVIDES ASYNCHRONOUS, ANONYMOUS SUPPORT BY TRAINED PEERS AND MENTAL HEALTH PROFESSIONALS. THIS HAS ALMOST 2000 USERS THAT ARE SUPPORTED THROUGH A WARM LINE OF VOLUNTEERS WHO RESPOND WITHIN TWENTY FOUR HOURS. VETERINARY MENTAL HEALTH SUPPORT (VMHS) PROVIDES PSYCHO-EDUCATIONAL SUPPORT AND INDIVIDUAL SESSIONS FACILITATED BY TRAINED PROFESSIONALS TO THOSE WORKING WITHIN THE VETERINARY INDUSTRY. THESE ARE FREE SERVICES AND HAVE REACHED OVER 400 INDUSTRY PROFESSIONALS IN 2025. NOMV'S EDUCATIONAL PROGRAM PROVIDES RESOURCES, WEBINAR, SKILL BUILDING ACTIVITIES, AND SUPPORT ON WELLBEING TO THE VETERINARY COMMUNITY. NOMV ATTENDED 10 CONFERENCES, SPOKE AT OVER 100 EVENTS, AND SHARED ONLINE RESOURCES WITH THOUSANDS IN 2025. NOMV'S CLEAR BLUEPRINT IS A PRACTICE CERTIFICATION PROGRAM SUPPORTING THE WELL-BEING OF THE COMMUNITY BY ASSESSING CLINICS FOR TEN WELL-BEING CATEGORIES, PROVIDING RESOURCES AND COACHING TO THE COMMUNITY. WE HAVE OVER 100 CLINICS IN PROCESS AND 43 CERTIFIED. IN 2017, NOMV BEGAN PROVIDING RESOURCES TO THE VETERINARY COMMUNITY IN TWO FORMS: FINANCIAL AND RESOURCE ACCESS. NOMV'S SUPPORT GRANTS PROVIDE UP TO \$500 FOR INDIVIDUALS WORKING WITHIN THE COMMUNITY WHO ARE EXPERIENCING FOOD, HOUSING, TRANSPORTATION, MENTAL OR PHYSICAL HEALTH INSECURITIES.
