All Blessings Flow is a local faith-based organization which collects, refurbishes, and redistributes used medical equipment free of charge to those in need throughout Charlottesville, VA and the surrounding areas. We rely on the kind gifts of friends and partners in our community including many medical and rehab professionals who contact us on a daily basis to assist their elderly and low income patients. Every dollar contributed goes directly to support our program services.

The most recent Community Health Needs Assessment for our local health district revealed that limited access to healthcare resources affects thousands of Central Virginia residents. The lack of desperately needed healthcare items leads to more significant health disparities for our most vulnerable neighbors. To address this problem in 2025, All Blessings Flow (ABF) acquired 48,872 items of used medical equipment and medical supplies valued at \$2,847,990 which were carefully cleaned, repaired, and refurbished for redistribution. During the year, the organization distributed 45,832 items of used medical equipment and supplies valued at \$2,814,074. The organization distributed items free-of-charge to 11,096 uninsured or under-insured adults and children with disabilities and health impairments from 70 different cities and counties within the Commonwealth of Virginia and beyond. The Pediatric portion of our program "ABF Kids" involves our program coordinator, a retired pediatric therapist from UVA Health Children's Hospital, who works in close collaboration with the hospital, Blue Ridge Care Connection for Children, and other pediatric healthcare professionals to assess children with disabilities, provide adaptive resources for their special needs, and counsel families. The program helps needy families access medical services targeted to their child's unique healthcare needs. Blessed with an extensive inventory, we can provide families with pediatric equipment and adaptive items individualized for children based on their sizes and disabilities. In 2025, the ABF Kids program served 229 children with disabilities and special needs. In 2023, the organization also fully established ABF Mobile, a community outreach initiative to improve rural healthcare access by delivering our services to underserved rural populations. Our mobile trailer unit travels and sets up one day each week at neighborhood sites in five surrounding counties. We collaborate with church partners in each county, with volunteers from local churches working alongside our site leader to help facilitate the program and reach more families in need. In 2025, we served 3,448 clients and their families in the five ABF Mobile counties. In addition to the ABF Kids Pediatric Program and ABF Mobile Rural Outreach Program, All Blessings Flow has multiple programs to help those with disabilities and their caregivers and families. ADL (Activities of Daily Living) Program: Our ABF therapists work closely with PTs and OTs who refer their patients to ABF. Working together, we assess patients' needs and provide essential healthcare assistive and adaptive devices for bathing, toileting, dressing, eating & drinking, getting in & out of bed or a chair, and standing from a sitting position. Adaptive Mobility Program: Our program coordinator and ABF therapists collaborate closely with local orthopedists, rehab facilities, PTs, and OTs who refer their patients to ABF. Working together, we assess the patients and provide adaptive mobility equipment that specifically fits their unique needs. We also offer counseling and training in the proper use of the equipment, including canes, crutches, walkers, rollators, knee scooters, and various sizes and types of manual wheelchairs. Caregiver Support Program: Many of our volunteers are or have been professional and family caregivers. They work with other caregivers who come to ABF to help and provide counsel and essential resources and supplies such as incontinence pads, adult briefs, bed pads, gloves, wipes, and most anything one might need to care for someone. Complex Rehab Technology Program: Our program coordinator is an expert in assistive technology who works closely with several AT professionals who offer their expertise when refurbishing power wheelchairs, power sit-to-stand lifts, and other complex rehab tech. He assesses each patient and consults with a PT/AT specialist to find the right adaptive technology for our disadvantaged patients with various forms of paralysis, neuro-muscular disorders, strokes, spinal cord injuries, and amputees. Hospital Bed Program: Our program coordinator collaborates closely with local hospitals, rehab facilities, and home health providers who refer their patients being discharged home or to a skilled nursing facility. Our expert technicians counsel and train patients and caregivers on the proper use and care of electric beds, and they often pick up and deliver beds to homes and facilities. Lymphedema Program: Our program coordinator is an OT with extensive experience in comprehensive decongestant therapy to manage swelling, reduce fluid buildup, and prevent infection. She inspects and tests all compression garments (sleeves, socks, and stockings) and pneumatic compression devices, and counsels and trains patients in their proper use. Ostomy and Enteral Nutrition (tube feeding) Program: Our program coordinator is an OT, a colorectal cancer survivor who had a colostomy, and was a caregiver to her mother, who had a tracheostomy. We work with local oncologist and nurses who refer cancer patients with limited means. We help with counseling and training and provide ostomy supplies and tube-feeding supplements. Respiratory Program: Our program coordinator is a retired ICU nurse who collaborates closely with UVA, Sentara, and other pulmonologists who refer their patients with limited means to ABF. All patients bring their doctor's orders and sit for a consultation session as we work to fit and calibrate assistive breathing devices such as BiPAP and CPAP machines and train the patients in their proper use. Another ABF volunteer is a respiratory therapist who works specifically with Spanish-speaking patients. Self-monitoring Blood Pressure and Diabetes Program: Our program coordinators are volunteer nurses who inspect and calibrate all our BP monitors and glucometers to ensure they are working properly and accurately. Periodically, UVA nursing students with Project SAVE also volunteer to offer free BP screening and provide home BP monitors for patients with elevated blood pressure readings. Vision & Hearing Program: ABF collaborates closely with a teacher from the Virginia Department for the Blind and Vision Impaired who inspects and test all our vision assistive devices and helps with assessments and referrals. We also work closely with a few local audiologists who conduct hearing tests for our hard-of-hearing clients and calibrate the hearing aids we provide. Wound Care Program: Our nurses inspect, organize, and maintain all wound care supplies. They work with other nurses to help counsel and educate patients and caregivers about the specific wound care resources they need, which ABF provides. The equipment resources we provide through all segments of our program help children, adults, seniors, and their families lead safer, healthier, and happier lives.

The organization has developed a digital Disability Resource Guide which brings together a comprehensive network of resources committed to providing the tools, services, and support needed to improve the quality of life of every adult, senior, or child living with a disability in our community. With 16 different categories and over 400 links to vendors and agencies, the guide consolidates invaluable resources covering all forms of disability including physical, intellectual, developmental, sensory, and/or mental challenges. Our vision is to provide individuals, caregivers, and healthcare professionals with an easy way to connect to our area's many excellent resources. In addition, the resource guide generates revenue that helps to support our mission through corporate sponsorships. Collectively, our sponsors paid \$7,500 total for the privilege of adding their name and logo to the site. Sponsorship is not a requirement to be listed on the site. That form includes personal identification, demographic information, specific health questions, and a liability waiver. Completed intake forms are collected weekly, and data is processed by several of our volunteers. We maintain multiple databases in which data is organized and analyzed for our different programs. Following data input, all intake forms are maintained in binders, organized chronologically by month and year. Within a few weeks of their initial visit, we conduct follow-up interviews with grantees to assess their health status and determine if their need for equipment and supplies has been met and if they have other healthcare needs at this time.
