FOR PURPOSES OF ESTABLISHING THE PRESENCE OF A QUORUM, THE INTERESTED PARTY OR PARTIES WILL BE COUNTED AMONG THOSE PRESENT AT THE MEETING. ALL QUESTIONS AS TO WHETHER A CONFLICT OF INTEREST EXISTS WILL BE RESOLVED BY A VOTE OF THE BOARD, WITH THE RELEVANT INDIVIDUAL(S) REFRAINING FROM ANY DELIBERATIONS (OTHER THAN TO RESPOND TO ANY QUESTIONS) AND VOTING.
