Camp Morris is a residential summer camp for youth living with type 1 diabetes. In 2025, the program served 178 campers. Of those, 44 received full or partial scholarships and 133 attended with subsidized tuition. Campers engaged in a wide range of recreational activities while being supported by 167 volunteer counselors, 93% of whom live with type 1 diabetes themselves. The program emphasizes not only recreation but also the development of diabetes management skills, confidence, resilience, and peer connection. These teachable moments are woven into daily activities, creating a lasting community of support. Medical care was provided by volunteer medical professionals from Atrium Health, Cone Health, Duke Health, Novant Health, UNC Health, Tryon Medical Partners, WakeMed, and private practices throughout North Carolina. At the conclusion of camp, 95% of campers reported feeling excited to return, 95% of caregivers observed an increase in their child's positive mental attitude, and 100% of staff reported feeling empowered in their roles.

Other Program supporting expenses - PMA Care Package Program expanded in 2025, with 80 care packages sent during the year, bringing the total to 257 packages delivered since the programs launch in October 2023. Packages were assembled by 20 volunteers and distributed to individuals across the United States. The program aims to support individuals experiencing diabetes burnout by reducing feelings of isolation and promoting mental well-being. Each package included type 1 diabetes resources, mental health support items, and a personal handwritten letter from a fellow T1D community member focused on cultivating a positive mental attitude. 90% of recipients reported feeling less isolated after receiving their package. Community Support Events include a variety of programs that serve individuals and families impacted by type 1 diabetes across North Carolina. These offerings include both virtual and in-person support groups such as Coffee and Conversation, Real Talk, and one-on-one mentorships. Each initiative is designed to provide emotional support, foster community connection, and reduce the isolation often felt by those living with or caring for someone with type 1 diabetes.

Fall Retreats is a weekend program designed to help teens and families navigate type 1 diabetes together through education, connection, and empowerment. In 2025, the program served 33 teens and 34 family members. 16 individuals received full scholarships to attend. Participants were supported by volunteer staff members, all of whom live with type 1 diabetes, providing relatable guidance and mentorship. Medical professionals also volunteered their time to offer ongoing education and medical support throughout the weekend. At the close of the retreat, 90% of participants reported feeling more confident in managing type 1 diabetes, and 100% of caregivers reported gaining new tools and strategies to support their loved ones.

Camp to Community programs continued to expand in 2025, reaching individuals and families across North Carolina who lack access to a diabetes community. In 2025, The Diabetes Family Connection hosted events in Hickory, Boone, Durham (Duke Diabetes Day), and Wilmington, partnering with the YMCA across North Carolina to bring one-day events, caregiver education sessions, and resource-sharing to families impacted by type 1 diabetes. Across all events, 12 education sessions were held, more than 1,000 resources were shared, and 100% of participants reported making a meaningful connection and feeling empowered. Medical and volunteer counselors provided both essential services and peer guidance at each event.
