MOBILIZE RECOVERY, LAUNCHED IN 2018 THROUGH THE FACEBOOK COMMUNITY LEADERSHIP PROGRAM, CONTINUED ITS MISSION TO EMPOWER AND CONNECT RECOVERY ADVOCATES NATIONWIDE. IN 2024, THE ORGANIZATION TOOK ITS ADVOCACY EFFORTS ON THE ROAD WITH A NATIONWIDE BUS TOUR THAT MADE 27 STOPS IN 13 STATES. BUILDING ON THIS MOMENTUM, 2025 WAS DESIGNATED AS A "YEAR OF ACTION," HIGHLIGHTED BY THE LAUNCH OF THE CAMPUS SURGE INITIATIVE. THIS FALL TOUR BROUGHT RECOVERY LEADERSHIP DIRECTLY TO COLLEGE CAMPUSES, JOINING FORCES WITH END OVERDOSE AND COLLEGIATE COMMUNITIES TO DISMANTLE BARRIERS AND CHAMPION MENTAL HEALTH AND RECOVERY AWARENESS. THE 2025 CAMPUS SURGE TOUR INCLUDED: 16 EVENTS ACROSS 15 STATES, UNITING MORE THAN 6,500 STUDENTS, FACULTY, AND COMMUNITY LEADERS. NATIONAL CO-CHAIRS INCLUDING AMERICAN IDOL WINNER NOAH THOMPSON, JELLY ROLL, MELISSA ETHERIDGE, AND DARREN WALLER, WHOSE VISIBILITY HELPED NORMALIZE RECOVERY IN CAMPUS CULTURE. HIGH-IMPACT STOPS AT INSTITUTIONS SUCH AS UNLV, RUTGERS UNIVERSITY, OHIO STATE, GEORGETOWN, AND TEXAS TECH, FEATURING ADVOCACY WORKSHOPS, EMPOWERMENT TRAININGS, AND LIVE MUSIC. THE YEAR'S EFFORTS ALSO INCLUDED THE ANNUAL MOBILIZE RECOVERY DAY OF SERVICE, WHICH SAW RECORD-BREAKING ENGAGEMENT IN 2025 WITH 781 COMMUNITY- LED SERVICE PROJECTS NATIONWIDE. THIS INITIATIVE CONTINUES TO DEMONSTRATE THE POWER OF RECOVERY BY UNITING THOUSANDS OF VOLUNTEERS TO GIVE BACK TO THEIR LOCAL COMMUNITIES THROUGH FOOD DRIVES, PARK CLEANUPS, AND RESOURCE DISTRIBUTION.

MOBILIZE RECOVERY'S OVERDOSE RESPONSE INITIATIVE HAS MADE SIGNIFICANT STRIDES IN COMBATING THE OVERDOSE CRISIS THROUGH OUR FREE NALOXONE DISTRIBUTION PROGRAM. IN 2025, THE INITIATIVE REACHED A HISTORIC MILESTONE, SURPASSING 1 MILLION DOSES OF NALOXONE DISTRIBUTED NATIONWIDE SINCE ITS INCEPTION. KEY HIGHLIGHTS FROM 2025 INCLUDE: 120,000 FREE DOSES DISTRIBUTED IN 2025 ALONE THROUGH A NATIONAL ALLIANCE OF NEARLY 40 ORGANIZATIONS.
