CASA of the Pikes Peak Region provides a volunteer's voice in court for children who are victims of abuse, neglect, or domestic conflict and promotes community awareness of these issues to ensure safe and permanent homes.

Children's Advocacy Program provides a volunteer's voice in court for children who are victims of abuse, neglect, or domestic conflict and gets them to a safe and permanent home as quickly as possible. We served 527 children in this program during FY25. 82% of our closed cases achieved permanency, 81% did not experience more than two placement moves while CASA was on the case, and 100% of the children served did not experience re-abuse or re-neglect. Continues in Schedule O The Supervised Exchange and Parenting Time Program (SEPT) is a court ordered service to protect children from witnessing parental disputes during visits or exchanges, where program volunteers oversee visits or the transfer of children from one parent to another in conflictive custody or domestic violence cases. We served 138 children in this program during FY25. We served 91 families, completed 453 exchanges, 1,156 visits, and zero incidents were reported. The Milton Foster Children's Fund (MFCF) provides foster children with opportunities not funded through other agencies. These needs include scholarships for sports and recreation, specialized education, and unmet needs, among others. The Hanger Project, an MFCF program, is a store with used clothing and accessories for adolescents in foster care. The adolescents may select five items per month. The teens also work in the store and learn job skills. CASA offers weekend classes on life skills, jobs, and career building to strengthen their opportunities as they move toward adulthood. During FY25 we served 134 children through individual grants, 246 teens through The Hanger store, and 133 teens through our teen programs. The Children and Families in Transition Program (CFIT) educates parents about the effects of divorce on children, the legal aspects of custody arrangements, and the negative effects of parental conflict on children. In FY25 we served 1,652 parents in this program.

Part I, Line 2:	<p>The Milton Foster Children's Fund (MFCF) program provides youth in foster care with enrichment and educational opportunities, typically not available through other agencies, that help them build the self-esteem and resiliency needed to become healthy, contributing adults. The program was named in honor of long-time CASA volunteer, Dick Milton. MFCF funding helps youth in foster care where there are gaps in available funding. Requests fall into three categories: 1. Educational: tutoring, school trips, graduation items, instruments, etc. 2. Skills and social: lessons, fees, or supplies for classes or hobbies, day or overnight camps, etc. 3. Health: items not covered or fully covered by insurance such as dental procedures, sensory or therapeutic items. Youth ages 0-18 living in out-of-home placement (or one funded request if living with biological parent(s)) and currently placed through El Paso or Teller County with an open dependency and neglect case are eligible for funding. Funding application guidelines: Youth can receive funds totaling no more than \$250 per CASA's fiscal year (July 1-June 30). This amount can be the full amount or multiple requests not exceeding \$250. Youth who live with a biological parent may have one request funded per the guidelines above. Applications may be filled out by anyone CASA, guardians, caseworkers, the youth themselves, etc. No funds will be given without a completed and approved MFCF application. The only exception to this rule and an application must be submitted and approved before a reimbursement is made is if the payment must be paid with the registration, for example paying the deposit on a summer camp. Checks must be made out to the vendor providing services (e.g., the dance studio) and will not be made out to the guardian or CASA. Checks will then be mailed to the placement's home address. Items that may only be purchased online with a credit card (e.g., therapeutic items on Amazon) will be paid for by CASA and shipped directly to the placement's home address. Applications are reviewed every Friday at noon in order to request and mail checks out the following week.
