 The organization collects and distributes hygiene products to individuals and families in crisis through partnerships with community organizations serving survivors of domestic violence, low-income families, and individuals experiencing hardship.

28 The Personal Care Foundation collects and distributes hygiene products to individuals and families in crisis through partnerships with social service organizations. In 2025, the organization distributed 612 hygiene care packages and 16,516 individual hygiene items to nonprofit partners serving survivors of domestic violence, low-income families, and individuals experiencing hardship. Care packages included essential items such as shampoo, conditioner, soap, deodorant, menstrual products, toothbrushes, and other personal care items. Partner organizations included local social service agencies and community nonprofits that provide direct support to vulnerable populations. These partnerships ensure that hygiene products reach individuals who may otherwise lack access to basic personal care supplies. The total estimated retail value of distributed items in 2025 was approximately \$15,063.
