During the year ended December 31, 2025, Wounded Waters, Inc. served veterans and first responders through its core programs of therapeutic fishing trips, scuba diving certification, and food distribution. The Organization conducted multiple fishing trips between February and August, serving a total of 13 veterans and first responders across scheduled outings. Wounded Waters became affiliated with SDI (Scuba Divers International) for dive training, purchasing six e-learning courses and certifying seven individuals in diving during the year. The Organization hosted the Circle of Heros Dive in September, with 13 veterans and first responders attending over two days. In March, the Organization purchased three steers, one goat, and one pig at the Indian River County Youth Livestock and Horticulture auction during the Firefighters Fair, coordinating with Dogs For Life, Inc. to distribute the meat to veteran and first-responder families.
