Those Vincentians now have funds to feed, teach, heal, clothe, house...in short love the people they serve. Among the projects VIMS funded were: -Bicycles for families in Burundi who are now able to get to school, work, and emergency situations much faster and more easily by way of bicycle. Donors provided \$25,000 to supply these bikes. -300 refugee families in Rwanda now have a goat to provide milk and nutrition. Thanks to the way goats reproduce, this is a very sustainable program. -Communities in Papua New Guinea, Cameroon, Eritrea and Nigeria are are enjoying clean water thanks to the well-drilling VIMS funded through donor gifts. -Moms and Dads in Peru are in classes preparing for employment in that countrys expanding tourism industry.
