This year we streamlined teams and combined a few to have more clarity. We also added a Team Lead Gathering monthly to offer support, training and opportunities for belonging and connection. **Emberlight hosted a Volunteer Fair for volunteers to determine which opportunity works best for them and & training for all volunteers through our four Volunteer Immersions. **We also hosted a 2-day Volunteer Team Lead Retreat

Direct Care of Residents Training & Support: **Emberlight offered 4 training opportunities for Direct Care volunteers caring for dying residents and their families; 8 Skills Labs where volunteers learned specific skills for the bedside, and 6 supplemental trainings on grief, dementia, equity & diversity, and end-of-life options. **Emberlight supports the organization and leadership through weekly coordination meetings, monthly all-team workdays with specialized training, and professional development opportunities for staff. ** Emberlight offered its second Doula Program that includes a retreat, online portion, and on-site apprenticeship learning **Emberlight launched a Mentor Training monthly education series and a Lead Doula training as well as On-Call and Medication/Hospice Training for volunteers who qualified. **The Director of Residential Care sent weekly newsletters to update all direct care volunteers of changes in care, changes in resident status, and updates on direct-care specific learning opportunities.
