28 In 2025, Friends of the Chicago Harbor Lighthouse (FOCHL) continued advancing its mission to preserve, restore, and promote the historic Chicago Harbor Lighthouse. The organization achieved key milestones in the National Historic Lighthouse Preservation Act (NHLPA) transfer process, including submission of required materials and securing State Historic Preservation Office support. FOCHL expanded public engagement through educational outreach, volunteer initiatives, and increased digital communications, strengthening awareness of the lighthouses historic significance. The annual Light the Way fundraising event sold out and generated meaningful support for restoration efforts, complemented by successful Giving Tuesday participation and major donor commitments. FOCHL also enhanced member and visitor engagement through participation in the U.S. Lighthouse Society Passport Program and ongoing public presentations. The organization maintained its strong commitment to transparency, governance, and responsible stewardship as it builds toward long-term restoration and preservation of the lighthouse.
