THE CITY AND BOROUGH OF JUNEAU (CBJ) CONTRACTS WITH JUNEAU ANIMAL RESCUE TO PROVIDE ANIMAL CONTROL AND PROTECTION SERVICES FOR THE COMMUNITY. ANIMAL CONTROL OFFICERS ENFORCE CBJ ANIMAL CONTROL AND PROTECTION ORDINANCES AND ARE AVAILABLE 24 HOURS A DAY, 7 DAYS A WEEK, YEAR-ROUND TO ENSURE THE SAFETY AND WELFARE OF ANIMALS AND RESIDENTS. OFFICERS RESPOND TO A WIDE RANGE OF ANIMAL-RELATED CASES, INCLUDING HUMAN AND ANIMAL BITES, STRAY AND INJURED ANIMALS, SUSPECTED ABUSE OR NEGLECT, AND ABANDONED OR LOST ANIMALS. THEY ALSO ASSIST COMMUNITY MEMBERS EXPERIENCING CHALLENGES WITH ANIMALS OR THEIR OWNERS. DURING FISCAL YEAR 2025, ANIMAL CONTROL OFFICERS RESPONDED TO 6,742 CALLS FOR SERVICE, IMPOUNDED 431 ANIMALS, AND SAFELY RETURNED 271 ANIMALS TO THEIR OWNERS.

JUNEAU ANIMAL RESCUE PROVIDES SHELTER AND CARE FOR DOMESTIC ANIMALS IN THE CITY AND BOROUGH OF JUNEAU. WE ARE THE ONLY BRICK-AND-MORTAR SHELTER IN JUNEAU AND THE LARGEST SHELTER IN SOUTHEAST ALASKA. AS AN OPEN-ADMISSION SHELTER, WE ACCEPT ANY ANIMAL THAT IS SURRENDERED TO US, FOUND WITHOUT AN OWNER, OR IDENTIFIED AS ABANDONED, NEGLECTED, OR ABUSED. ALL ANIMALS IN OUR CARE RECEIVE A BASIC HEALTH EXAM AND VACCINATIONS. IF THEY ARE NOT CLAIMED, THEY ENTER OUR ADOPTION PROGRAM, WHERE THEY REMAIN UNTIL PLACED IN A SUITABLE HOME. ALL DOGS, CATS, FERRETS, RABBITS, AND SOME SMALL ANIMALS ARE SPAYED OR NEUTERED AND MICROCHIPPED. DOGS ADOPTED FROM OUR FACILITY ARE ALSO REQUIRED TO BE LICENSED PRIOR TO LEAVING THE PREMISES. DURING FISCAL YEAR 2025, THE SHELTER TOOK IN 600 OWNER-SURRENDERED, STRAY, OR ABANDONED ANIMALS, SUPPORTED ADDITIONAL ANIMALS THROUGH SAFEKEEPING SERVICES, AND ADOPTED OUT 402 ANIMALS TO NEW HOMES. JUNEAU ANIMAL RESCUE ALSO PROVIDES LIMITED SUPPORT TO COMMUNITIES THROUGHOUT SOUTHEAST ALASKA BY TAKING IN UNWANTED OR NEGLECTED ANIMALS FROM AREAS WITHOUT LOCAL SHELTER, FOSTERING, OR VETERINARY SERVICES, AND BY COORDINATING THE TRANSFER OF ANIMALS IN OUR CARE TO NEIGHBORING COMMUNITIES WITH ESTABLISHED SHELTER OR FOSTERING PROGRAMS.

THE JUNEAU ANIMAL RESCUE CLINIC IS RESPONSIBLE FOR THE HEALTH AND WELFARE OF ALL ANIMALS IN OUR CARE, AS WELL AS PROVIDING SERVICES TO PRIVATELY OWNED PETS IN THE COMMUNITY. EACH YEAR, WE DELIVER EMERGENCY CARE AND OFFER SUPPORT FOR TRAINING AND BEHAVIORAL ISSUES. IN FISCAL YEAR 2025, WE PROVIDED 1,021 LOW-COST RABIES VACCINATIONS AND IMPLANTED 332 MICROCHIPS FOR COMMUNITY PETS. WE ALSO OFFER BOARDING AND LIMITED MEDICAL SERVICES AT REDUCED COST FOR ANIMALS BELONGING TO INDIVIDUALS WHO ARE INCARCERATED OR TEMPORARILY HOUSED IN PUBLIC OR PRIVATE SHELTERS. DURING THE SAME PERIOD, OUR VETERINARY CLINIC PERFORMED 542 SPAY AND NEUTER SURGERIES, INCLUDING 121 PROVIDED AT LOW OR NO COST TO INCOME-QUALIFIED INDIVIDUALS. IN ADDITION, WE OCCASIONALLY PROVIDE CONSULTATION SERVICES TO SHELTERS IN OTHER SOUTHEAST ALASKA COMMUNITIES, ASSISTING WITH A VARIETY OF ANIMAL CARE AND WELFARE CHALLENGES.
