Chasing the Rainbows provides free, trauma-informed virtual peer-led support groups for individuals and families navigating infertility, pregnancy loss, stillbirth, infant loss, and pregnancy after loss. These groups are facilitated by trained peer leaders with lived experience and provide compassionate spaces where participants can process grief, reduce isolation, and connect with others who understand their journey. In addition, the organization maintains a moderated online community and chat platform that allows members to access support, share experiences, and connect with others at any time. Together, these services provide accessible, ongoing support to families nationwide.

Peer Mentorship and Therapeutic Support Chasing the Rainbows offers a peer mentorship program that thoughtfully matches individuals navigating infertility or pregnancy and infant loss with trained mentors who have lived experience and are further along in their healing journey. Mentors provide one-on-one emotional support, encouragement, and guidance during a deeply vulnerable time. The organization also provides access to trauma-informed therapeutic support and resources to help individuals and families navigate the complex emotional and mental health impacts of reproductive loss and grief.

Hospital Outreach and Educational Awareness Chasing the Rainbows conducts outreach to hospitals, OB/GYN departments, maternal-fetal medicine specialists, NICUs, and fertility clinics to build partnerships that increase awareness of the emotional and mental health impact of infertility and pregnancy and infant loss. Through these partnerships, healthcare providers are able to connect patients and families with free support resources offered by the organization. The organization also produces educational podcast content featuring physicians, mental health professionals, and individuals with lived experience to raise awareness, provide evidence-based information, and expand access to education and support for families and healthcare providers nationwide.
