APPROXIMATELY 250 VOLUNTEERS ASSIST IN THE CAMPAIGN'S ACTIVITIES.

THE FOCUS IS ON THE BARRIERS LOW-INCOME OREGONIANS FACE IN ACCESSING CIVIL LEGAL AID.
