CORNERSTONE CRAFTSMAN OPERATES A PRE-APPRENTICESHIP WORKFORCE DEVELOPMENT PROGRAM SERVING YOUTH FROM UNDERSERVED AND AT-RISK COMMUNITIES IN ALEXANDRIA, VIRGINIA. THE PROGRAM PROVIDES VOCATIONAL TRAINING IN THE SKILLED TRADES, MENTORSHIP, AND CAREER READINESS SUPPORT TO PROMOTE LONG-TERM ECONOMIC SELF-SUFFICIENCY. IN 2025, THE ORGANIZATION SERVED 36 YOUTH, WITH 28 ACTIVELY PARTICIPATING ON A WEEKLY BASIS AND MAINTAINING A 97% RETENTION RATE. PARTICIPANTS ENGAGED IN HANDS-ON TECHNICAL TRAINING, WORKFORCE DEVELOPMENT WORKSHOPS, AND INDUSTRY EXPOSURE, EARNING CREDENTIALS INCLUDING OSHA-10 (30 YOUTH) AND CPR/FIRST AID CERTIFICATIONS (27 YOUTH). THE PROGRAM PROVIDES HOLISTIC SUPPORT SERVICES TO REDUCE BARRIERS TO EMPLOYMENT, INCLUDING ASSISTANCE OBTAINING ESSENTIAL DOCUMENTS, ENROLLING IN DRIVER EDUCATION PROGRAMS, AND COMPLETING REQUIREMENTS FOR DRIVER'S LICENSES. ADDITIONAL SERVICES INCLUDED ACADEMIC TUTORING THROUGH THE ORGANIZATION'S LEARNING LAB AND THE DISTRIBUTION OF FOOD TO OVER 120 INDIVIDUALS TO ADDRESS FOOD INSECURITY. CORNERSTONE CRAFTSMAN ALSO SUPPORTS COURT-INVOLVED YOUTH THROUGH MENTORSHIP AND ADVOCACY, HELPING PARTICIPANTS ACHIEVE POSITIVE OUTCOMES SUCH AS SUCCESSFUL PROBATION COMPLETION, ENTRY INTO APPRENTICESHIPS, AND EMPLOYMENT OPPORTUNITIES.
