All medical and dental services at the Clinic were done at zero cost to the client. This includes things like STI, hepatitis, HIV screening and treatment, dental preventive and acute care, UTI testing and treatment, and TB testing. The Clinic served 2007 clients and 3,153 encounters with these services. Additionally, the Clinic provided local community referrals via our help desk, social assistance enrollment, homeless community outreach, and peer-to-peer counseling.
