THE PARK PROVIDES EDUCATIONAL, RECREATIONAL AND COMPETITIVE EQUESTRIAN OFFERINGS THAT ENCOURAGE THE GROWTH AND DEVELOPMENT OF YOUTH AND ADULTS.
