Audience attendance is between 200 and 300 patrons. The audience consists of people from Sedona, Verde Valley, Northern Arizona, the Phoenix area and international visitors. The musicians are among the finest in the world, brought to Sedona by our Artistic Director.

Sedona Chamber Music Society expanded the music education program to include funding for individual music lessons plus engagement in the new Sedona Community Youth Orchestra.
