Economic Empowerment: * Connected underrepresented individuals with employment opportunities through the Non-Tech Jobs in Tech initiative and related workforce development programming. * Partnered with Home Depot and the Home Builders Institute to provide Pre-Apprenticeship Certification Training (PACT) to 183 students, with approximately 76% transitioning into work-based learning, advanced training, or college pathways. * Hosted a Career Expo featuring 12 career pathways and resulting in immediate employment offers for participating youth. * Conducted Economic Empowerment workshops and seminars reaching 226 participants through business, homeownership, and wealth-building educational events.

Health & Wellness: * Operated the Youth Movement program, providing youth fitness and life skills training, with more than 90% of participants achieving Healthy Fitness Zone benchmarks. * Hosted the Tommie Smith Youth Track Meet, serving 1,381 youth athletes representing 29 teams and 45 unattached participants, while also supporting international athletic and cultural exposure opportunities. * Delivered over 450 free mental health therapy sessions to 166 participants through the Mental Health Financial Assistance Program, providing more than \$200,000 in financial assistance to underserved communities. * Conducted additional wellness initiatives, including a Sickle Cell Blood Drive and participation in national health and wellness leadership efforts.

Education * Raised \$82,000 through the Annual Scholarship Golf Classic in support of student scholarships, contributing to more than \$2.3 million in cumulative scholarship assistance awarded by the Chapter. * Operated the Dollars and Sense Financial Literacy Competition, a 14-week educational program teaching youth and families budgeting, saving, investing, and financial planning skills. * Connected students with STEM professionals and higher-education opportunities through the Knowledge, Math & Technology (KMT) Program, including college tours and career exposure activities. * Relaunched the Collegiate 100 auxiliary Chapter at Peralta Colleges with mentorship and community engagement programming.
